

## **PRESS RELEASE FROM THE SAVE THE CABINET ACTION GROUP**

### **Campaigners welcome support for Council borrowing to buy local pub**

Campaigners hoping to prevent the Grade II listed Cabinet pub at Reed being turned permanently into a house have welcomed the results of a survey carried out by Reed Parish Council.

82% of those surveyed approved of the idea of the Parish Council borrowing to buy the pub on behalf of the community if it came on the market, with 10% against and 8% undecided. The return rate for the survey was 91%. This followed a public meeting in November which also showed strong support for the proposal.

A government body called the Public Works Loan Board makes loans to parish councils at preferential rates, and such loans can be used to save local pubs and other facilities. As a first step, parish councils must seek permission from the Secretary of State for Communities, Housing and Local Government to borrow the money.

The present owner of The Cabinet, a property developer, turned the building into a house without planning permission or listed building consent, only applying for these retrospectively. In July last year, North Hertfordshire district councillors refused planning permission for change of use of the building to a private house. The developer has now lodged an appeal, which awaits validation by the Planning Inspectorate.

Mike Howes, chair of the Save the Cabinet Action Group, said

“We welcomed Reed Parish Council’s initiative to see if there is public support for buying the pub on behalf of the community and are delighted by the strong show of support for the idea. We know of interest from a potential private buyer and a local consortium, but this would provide a new option for reopening The Cabinet as a pub.

“Meanwhile we need to raise money urgently to cover the costs of making our case at the appeal as effectively as possible.”

On Saturday (10 February), the Action Group will host a Pop-up Pub night at Reed Village Hall to help raise money for the Save the Cabinet Fighting Fund. Similar events in the past have attracted around 100 supporters.

Mike added:

“We are committed to resisting the developer’s appeal with all the fortitude we can muster. But we urgently need to raise money to enable us to make the strongest possible case for getting our lovely old pub back.”

The Save the Cabinet Action Group was established in October 2016 to resist the application to turn The Cabinet at Reed into a house.

The Cabinet is a 400-year old building, and is considered a village icon – it even appears on the village sign. It is believed to be the only pub in Britain bearing the name.

The Cabinet was a thriving, popular pub, widely known as “a little gem”.

It closed in 2011 and was put up for sale. The Action Group provided evidence of several offers to buy the pub which were refused by the then owners. It was eventually sold at auction in late 2015 to the present owner for £375,000. Documents before the Planning Control Committee suggested that the building was, as a pub, valued at no more than £250,000.

The kitchen was removed during 2015, and further works were commenced in mid-2016 and have been ongoing since. The retrospective applications for planning and listed building consent were submitted in September 2016.

Although planning permission was refused by the members of the Planning Control Committee of NHDC in July, the linked listed buildings applications have not yet been determined.

The developer has lodged an appeal against refusal of planning permission for change of use. Interested parties, including objectors, will have a further opportunity to make representations and submit evidence at any hearing. The appeal will be heard by a planning inspector independent of North Herts District Council.

Under Section 9 Planning (Listed Buildings and Conservation Areas) Act 1990, carrying out work to a listed building without first obtaining the necessary consent is a criminal offence.
